#### LAW ENFORCEMENT REPORT

Deputy Jesse Kidder gave the August 2019 Sheriff report. Batavia Township Deputies took 189 offense reports for August, up 14% from July. There was \$2000 of stolen property recovered. There were 6 overdoses for the Township (two for the same individual). There were 3 burglaries.

#### **PUBLIC PARTICIPATION**

Mr. Parsons introduced Weston Gruber, who gave a power point presentation for his Eagle Scout Project, a gaga ball arena.

Ethan Kinner presented his Eagle Scout Project, Dog Park enhancements.

Tom Turchiano, Republic Waste/Recycling, gave his presentation on the first year of service.

Ed McCoy spoke as a proponent of dissolving the Amelia Village.

#### REPORTS OF THE ZONING ADMINISTRATOR/INSPECTOR

Denise Kelley, Zoning Administrator, and Brad Harris, Zoning Inspector, gave their August reports which included the Housing permits, and BZA and Zoning Commission updates.

### REPORTS OF THE SERVICE DIRECTOR

Mr. Embry gave an update on the 2019 Road Paving Program.

All the equipment is in for the new truck.

## REPORTS OF THE TOWNSHIP ADMINISTRATOR

Mr. Parsons spoke about the Stream side TIF/Amended agreement.

There was a resident complaint about drivers speeding on Filager Road. Mr. Parsons sent a letter to Jeremy Evans, Clermont County Engineer. A speed study has not been completed since 1996. Mr. Evans is hopeful the State will consider doing a speed study on Filager.

The Veteran's Services had their first annual family picnic at the Township Park. They sent a thank-you letter to the Batavia Township Trustees.

The Bulldog Blast 3 mile walk/run took place a few weeks ago. Mr. Parsons participated and won the race for his age group. There were 175 participants and raised about \$2000 for scholarships for Batavia Local School students.

The National Night Out was held August 6<sup>th</sup> at the Township Park. The Sheriff's office sent a letter of thank-you to the Township. Next year's NNO will be August 4, 2020.

The LFAW (League for Animal Welfare) is having an open house, Saturday, October 5 from 1-4 pm.

Mr. Parsons spoke about the Orion Roller Coaster at Kings Island. It supported jobs in Batavia Township because it was manufactured in Batavia, at Southern Ohio Fabricators in Afton.

The Trustees were given the Electric Aggregation Performance Summary.

Mr. Parsons has obtained quotes for security cameras for the Township Property.

There was a five minute break.

#### **OLD BUSINESS**

Mr. Parsons, Ms. Haley and Mr. Perry met with the State Auditors, etc. for planning purposes concerning the Village of Amelia dissolution on November's ballot.

Mr. Parsons spoke about the 2020 budget to include the sidewalk repair program.
