AMENDING CEMETERY FEE SCHEDULE

The Board of Trustees of Batavia Township, Clermont County, Ohio, met in regular session on the 6th day of August, 2025 at the Batavia Township Community Center with the following members present:

Trustee Mr. Sauls moved for the adoption of the following Resolution:

WHEREAS, the Batavia Township Board of Trustees is authorized to establish reasonable prices for the sale of cemetery lots in township cemeteries pursuant to Ohio Revised Code Section 517.07; and

WHEREAS, the Board desires to amend the existing Fee Schedule for Batavia Township cemeteries.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Batavia Township, Clermont County, State of Ohio:

SECTION 1. That the Board of Trustees hereby amends the Schedule of Fees for cemetery lots, interments and miscellaneous charges for the Batavia Township cemeteries as set forth in attached Exhibit A, and finds that the fees are reasonable.

SECTION 2. The Board does hereby dispense with the requirement that this Resolution be read on two separate days, pursuant to Section 504.10 of the Ohio Revised Code, and authorizes the adoption of this Resolution upon its first reading.

SECTION 3 . That this Resolution shall take effect from and after the earliest time allowed by law.



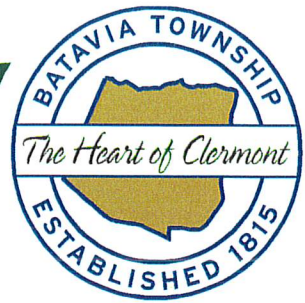
