RESOLUTION NUMBER 11-07-2022**

SETTING BASEBALL FIELD RENTAL RATES AND POLICIES

The Board of Trustees of Batavia Township, Clermont County, Ohio, met in regular session on the 1st day of November, 2022 at the Batavia Township Community Center with the following members present:

James E. Sauls, Jr.

Trustee Pauls moved for the adoption of the following Resolution:

WHEREAS, the Batavia Township Board of Trustees desires to set new rental rates and policies for the community baseball fields.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Batavia Township, Clermont County, State of Ohio:

SECTION 1. That the rental rates for use of the Batavia Township community baseball fields are as follows:

Teams with 50% or more ballplayers who are Residents of Batavia Township, per event:	\$25
If a team does not meet the 50% Batavia Township residency threshold, per event:	\$40

SECTION 2. That the rental application process includes the following policies and regulations:

Definition of Event: A game or a practice. A fee is required for each separate game or practice. For example, in the occurrence of a tournament with three separate games, three separate fees are required.

Definition of Resident: A Resident is defined as a resident who resides in the Township of Batavia as reflected by the Clermont County Auditor address records. For example, a resident who lives in the Township of Union, but has a 45103-zip code is not a Batavia Township resident.

Residency Test: To verify Batavia Township residency, in the field rental application, the Township will request a roster of addresses of the team members of the rental application (e.g., the home team).

Incomplete Roster Policy: If a roster of addresses is not supplied or is incomplete, the \$40 fee shall be applied.

Rain/ Wet Field Policy: Monetary refunds shall not be issued in the event of rain dates, but in the event of a rain or wet field cancellation, a rain check can be issued for a future date. Wet field or rain cancellations are determined at the sole discretion of the Township. If the Township deems the field playable, a rain check cannot be issued.

No-Show Policy: In the instance of a dry and playable field, monetary refunds shall not be issued for a no-show or in the absence of a team. In this case, the fee is forfeited. To reschedule a new event, a new fee is required.

The Township reserves the right to refuse the rental for any reason (such as a history of no-shows).

The applicant of the field rental assumes all risks related to the usage of the field.

Official UC Clermont games and practices are exempt and are subject to the MOU between the Township and the School.

Reservation of Event Policy: Reservations are on a per date, first come and first served basis. To guarantee a reservation, a complete application must be submitted and the reservation fee for the event must be paid in full prior to the event.

SECTION 3 . That this Resolution shall take effect from and after the earliest time allowed by law.




