**ADOPTING PARK SPLASH PAD RULES AND REGULATIONS**

The Board of Trustees of Batavia Township, Clermont County, Ohio, met in regular session on the 4<sup>th</sup> day of June, 2024 at the Batavia Township Community Center with the following members present:

Trustee *Sauls* moved for the adoption of the following Resolution:

WHEREAS, the Batavia Township Board of Trustees is authorized to adopt rules and regulations for the government and control of township parks pursuant to Ohio Revised Code Sections 511.32 and 755.13; and

WHEREAS, the Board desires to adopt such rules and regulations for the splash pad located at the Batavia Township Community Park.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Batavia Township, Clermont County, State of Ohio:

**SECTION 1.** That the Board of Trustees hereby adopts the rules and regulations attached hereto as Exhibit A for the use and operation of the splash pad located at the Batavia Township Community Park pursuant to Ohio Revised Code Sections 511.32 and 755.13.

**SECTION 2.** The Board does hereby dispense with the requirement that this Resolution be read on two separate days, pursuant to Section 504.10 of the Ohio Revised Code, and authorizes the adoption of this Resolution upon its first reading.

# Splashpad Rules

Splash Pad Hours of Operation: 10:00AM – 8:00PM

Memorial Day to Labor Day

Please use the Splash Pad / Playground at your own risk. This splash pad is an unsupervised facility.

An adult must accompany children under twelve (12) in the splash pad play area. No child shall be left unattended at the splash pad.

Proper attire must always be worn. Street shoes are prohibited on splash pad. Sandals, water shoes, flip flops or appropriate deck wear is recommended for splash pad.

Swim diapers are required for all children under the age of 4 years old.

Climbing on the splash pad features is strictly prohibited.

No pets or animals are allowed in the splash pad area.

No bathing, soap, detergent or shampoo allowed.

Do not use the splash pad if you have open cuts, sores, lesions, infections, obvious communicable disease, or diarrhea.

Be mindful of inclement weather. Remember, "Lightning Kills"! Splash pad / playground must be vacated at first sound of thunder or flash of lightning.

Splash pad may be closed at any time due to weather, maintenance, or other operational concerns.
