Mr. Parsons gave an update on the Amelia Olive Branch sidewalk project. This is completed. There is a solar panel which charges the battery for the lights. This was 100% paid by a grant.

Mr. Parsons has not heard anything else about the transfer of roads.

A special meeting is to be scheduled about the electric and gas aggregation.

The TIRC meeting went well. The five abatements were approved for extension. Superior Steel tax abatement does expire this year.

Superior Steel is doing so well; they will be leasing space on Curliss Lane, in Batavia Township.

There has been an issue of compliance on the parcel of 4771 Olive Branch Stonelick Road.

Mr. Parsons is working on preparing for the 2018 fireworks and concert in the park.

Mr. Parsons spoke about the Chapel Road and SR 132 intersection. Improvement options are being discussed to make it a safe intersection.

It is time to get CPR classes scheduled. Mr. Parsons will schedule everyone interested.

Mr. Parsons spoke about waste and recycling franchising. Mr. Parsons researched bidding and pricing.

Mr. Parsons met with the OTARMA representative last week. She was very impressed about the upkeep and maintenance of the park. Brad Harris will check the playgrounds regularly.

Mr. Parsons will submit the dog park grant this Friday. Another grant will be included for the warning siren.
