REPORTS OF THE SERVICE DIRECTOR

Mr. Embry has not received any information from the County about Snyder Road.

Mr. Embry gave a summary of the clean up days. At the Township Center, we took in 40 loads, 5 tires, on Friday. On Saturday we had 126 loads and 5 tires. At the 2401 location on Friday there were 30 loads and 5 tires. Saturday there were 138 loads and 13 tires.

There were 323 children at the Reds Rookie Success League. There were 270 children who had breakfast which was provided by United Health Ministries of Northern Kentucky.

We were overcharged for the election fees. Mr. Parsons is working on straightening this out.

An Ipad was purchased for Brad Harris.

Our new employees will start next week. Mr. Parsons met with both of them and they have all their paperwork.

The electric aggregation starts with the July billing. We will start on the gas soon to lock in on a price.

The trash is out for bid. The Adams Clermont Solid Waste District is handling the bids, opening and closing. They will be opened on the 25th.
