SHERIFF'S DEPARMENT REPORT

Deputy Benkelmann gave the crime stats for May 2024. There were 27 violent crimes, 39 property crimes, 8 personal crimes, 7 drug and alcohol related, 73 information reports, and 2 juvenile related offenses. This is an increase of about 13.5% from last month. There were 23 theft related offenses which was the highest crime type.

The Batavia Township Deputies took 104 offense reports and 135 incident reports. There were 22 traffic arrests, 40 warnings, 79 warrant services, 367 civil services, 56 assists to other departments, 36 adult arrests, 17 juvenile arrests, and 183 business checks. We took 80% of the incident reports as well as 63% of the offense reports. There was \$10,000 in recovered property which was a stolen vehicle. There were 393 neighborhoods patrolled. We had eight overdoses.

There are staff changes in the Sheriff's Department. Sheriff Leahy announced we have a Township replacement, Deputy Dillon Bailey. He is replacing Deputy Wallace, who is promoted to Corporal.

UC Clermont Baseball Team Recognition - 2024 National Champions

The Board recognized our UC Clermont Baseball Team, who plays on the Brian Wilson Field located at the Township Park. The team recently won the National Championship. Coach Keith Bauman spoke on behalf of the team. The Baseball Team won its first championship in 2013. The Board thanked Coach Bauman for taking great care of the field.

COMMITTEE REPORTS

Mr. Sauls gave an update for Central Joint Fire & EMS District. There were 363 runs last month which is a record. There were 133 fire runs, 30 inspections, and 1 re-inspection. There were 2 resignations. We had ten applications for basic EMT's, and one new hire which is a paramedic.

Mr. Parsons gave the update for Batavia Union Cemetery. They will meet tomorrow.

SERVICE DIRECTOR REPORT

Cody Smith, Service Director, gave the May report. Cody was congratulated on the birth of their daughter.

The Department performed ditching and a cross-culvert on Millhaven.

We resealed the decorative concrete around the dog memorial at the Township Park.

We received our new John Deere Tractor with the A-Boom attachment. We are very happy with this machine.

We correctly regraded the entire field, reseeded and strawed, and put in a drainage ditch at the old homeless shelter.

We put in a cross-culvert at Union Chapel. It is a 12-inch steel. Union Chapel is ready to be paved.

The paving has been completed in Clearbrook, Pebble Creek, and Wildbrook Court. We are supposed to finish up paving on Union Chapel, Midland, and all the side streets in Mt. Holly Preserves. Summit Road is held up as the County is replacing a bridge near Fox Run Lane.

There is an issue with the catch basin on Madison Park Drive.

There were 4 full burials and 1 indigent cremation in May. We completed a cemetery workday on May 16th.

Guardrail work on Greenbriar is scheduled to start on Thursday, June 6th. This should only be a couple of days. Next will be Snider Road.

Our new truck is complete and ready for pick-up.

PLANNING AND ZONING DIRECTOR/INSPECTOR REPORT

Taylor Corbett, Planning and Zoning Director gave the May report.

From May 15th through May 18th, Taylor attended a three-day meeting for the Congress of New Urbanism. This is for new ideas for planning, architecture, and engineering. We presented our project idea for the Amelia corridor. Taylor gave an update on Pike with a Purpose, including illustrations and recommendations. There was a GIS layover of the illustration which shows the amount of open space from an aerial view. This vision shows the pedestrian corridor for the shared townships.

There will be an extension of Winemiller Lane for the proposed Skyline.

Taylor went over a minor modification for The Ridge Project. There is a 4-phase development plan.
